I fully understand that Sun City Cats expect high standards of moral and ethical treatment of the cats under its care. I will adhere strictly to these standards in my capacity as a volunteer.

I will not destroy private property or trespass.

I will not post on social media, give interviews or talk to the media on behalf of Sun City Cats without prior approval of Sun City Cats Board of Directors.

Waiver and Release of Liability

I understand that the handling of animals and other volunteer activities including but not limited to TNR clinics, and fostering on behalf of Sun City Cats may place me in a hazardous situation and could result in injury to me or my personal property.

On behalf of myself, and my heirs, personal representatives and assigns, I hereby release, discharge, indemnify and hold harmless Sun City Cats and its directors, officers, volunteers, members and agents from any and all claims, causes of action and demands of any nature, whether known or unknown, arising out of or in connection with my volunteer activities on behalf of Sun City Cats.

I understand that Sun City Cats does not maintain an insurance policy covering any circumstances arising from my participation in any volunteer activities.
